- FY 22 ICDBG "Normal" (Imminent Threat funding available)
- FY 22 IHBG Competitive
- Notice of Funding Opportunity (NOFO) for the FY2021 Youth Homelessness Demonstration Program (YHDP). YHDP is an initiative designed to address systemic responses to youth homelessness and significantly reduce the number of youth experiencing homelessness. Through this NOFO, HUD will award approximately \$72 million in up to 25 participating communities, with a priority for communities with substantial rural populations in up to 8 locations. Submission Deadline: June 28, 2022.

- All other Grants (ICDBG/IT CARES ARP ROSS THUD VASH) SF-425 Reports are still submitted to your GM/GE Specialists for acceptance and processing.

- 2022 ASERS for <u>all</u> ICDBG awards are due November 14, 2022.
- Audits
  - 12/31/2020 FY End: March 31, 2022 due date
  - 9/30/2021 FY End: June 30, 2022 due date
  - 12/31/2021 FY End: September 30, 2022 due date
